Adopting "Juneteenth" as official holiday within RPBCWD's paid holiday schedule

Motion by Manager Crafton seconded by Manager Pedersen to adopt the following resolution:

WHEREAS, Juneteenth National Independence Day commemorates June 19, 1865 when the Union Army went to Galveston, TX to announce the emancipation of the last slaves in the United States and is recognized annually on June 19th,

WHEREAS, as of June 17, 2021, President Joseph Biden signed the Juneteenth National Independence Day Act into law, making it a federal legal holiday,

WHEREAS, as of June 18, 2021, Minnesota Governor Tim Walz declared June 19th to be Juneteenth Freedom Day,

WHEREAS, RPBCWD currently observes eleven holidays including New Year's Day, Martin Luther King's Birthday, President's Day, Memorial Day, Independence Day, Labor Day, Veteran's Day, Thanksgiving Day, Day after Thanksgiving Day, Christmas Day, and a Floating Holiday,

WHEREAS, according to the dully adopted Personnel Handbook, full-time employees are eligible for holiday pay on the day on which the holiday lands; if the holiday falls on a Saturday the preceding Friday will be the holiday, or if the holiday falls on a Sunday, the following Monday will be considered the holiday,
